As discussed in the meeting held in our regional office with regard to SIP 2017 today in the afternoon, we do hereby confirm the placement of students of your institute for the proposed internship program with our organisation as per the terms and conditions mentioned as under -

1. The internship shall be for sub-sector and value chain study of pineapple, jack fruit and skills (with focus on weaving).





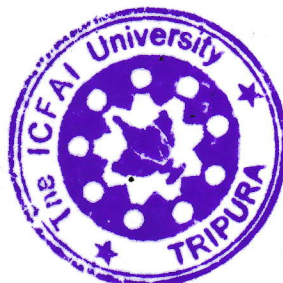
