

Founder's Profile

Mr. N. J. Yasaswy (1950-2011), founder of the ICFAI Group of educational institutions and a pioneer in promoting higher education in the private sector had a brilliant academic career: B.Com (Andhra University 1969 – First Rank), CA Inter (May 1971 – First Rank), CA Final (May 1973 – First Rank), ICWA Inter (July 1970 – First Rank) and ICWA Final (July 1972 – First Rank). He was the recipient of the Basu Foundation Award for the Best Student of the Year from both – The Institute of Cost and Works Accountants of India (in 1972) and The Institute of Chartered Accountants of India (in 1973).

During 1974-1980, Mr. Yasaswy was associated with the Administrative Staff College of India as a Faculty Member.

In 1981, he started his consultancy firm, Yasaswy Management Association (P) Limited, Hyderabad. Mr. Yasaswy was appointed by the Government of Andhra Pradesh as Chairman, Andhra Pradesh State Trading Corporation (1985-88), and Vice-Chairman, Public Enterprises Management Board (1986-88). He was a visiting faculty member at the Indian Institute of Management-Ahmedabad (1986-88) and was nominated as a Member on the SEBI Committee on Accounting Standards. He was a member of the Board of Directors of the Association of Certified International Investment Analysts (ACIIA), Switzerland. He authored several books on finance and investments.

Mr. Yasaswy set up the ICFAI as a single institute in 1985 without governmental support or institutional funding, in an era where government support was the norm. He chose to spend all his energy on the fledgling institution which over the years grew to become a monument to what ambition can deliver. He was instrumental in building several business schools and universities in the developing states of India, particularly in the North-East region. He stood for professional management, excellence in the quality of education offered in the ICFAI institutions, and absolute discipline.

He was charismatic, a great teacher, an institution builder, a visionary and a genius who was years ahead of his time. His vision will continue to guide ICFAI forever.

The M.A (Education) Program

The M A Education Program is offered on open & distance learning (ODL) mode by the ICFAI University, Tripura.

This is a two years post graduate program in Education. The objectives of the program are:

- To provide a wider scope to graduates who aspire to pursue post graduation in the field of education.
- To provide both a foundation in basic skills and the promotion of advanced skill.
- To create a community of scholars adequately equipped for participation in educational discourse to work on the policies and problems related to the world of education.

Program offers students, a unique opportunity to actively engage and thoughtfully process relevant issues in education. The advantages for the student are multidisciplinary approach to learning, modular curricula which facilitates wider choices for students ensuring cross-disciplinary education.

Program structure : The MA-Education Program is structured semester-wise. .

Eligibility: Pass in Graduation (in any discipline).

Age : No Bar.

Duration: Two years. Students shall be permitted to complete the program within a maximum of five years

Medium of instruction: English.

Self-Study:

The University provides required academic material designed for the programs meant for self-study

Examination:

Examinations are conducted four times in two years. The schedule of examination dates will be mailed to the student's registered email id.

Eligibility for appearing in examinations:

Students are eligible to appear for semester I examination (all five subjects) six months after the date of enrollment. Subsequently, students can complete each semester once every six months. Students will be required to progress in the program semester wise, sequentially. The students can appear in the back log paper in the subsequent examination. However, a back log subject can be carried forward. For example a back log subject of Semester I can be carried to Semester II & subsequently.
