Inaugural Session

He also expressed his pleasure in learning about legal education and its interdisciplinary relevance.

Following this, **Dr. Subholaxmi Mukherjee** addressed the gathering and elaborated on the role of the Constitutional Law Society in fostering legal awareness, critical thinking, and academic discourse among law students. Her address underscored the Society's commitment to promoting constitutional literacy through academic initiatives and outreach activities. She highlighted how constitutional values intersect with diverse academic disciplines and social realities.

Subsequently, **Dr. Romita Reang** shared her insights on constitutional education, emphasizing the importance of interdisciplinary learning in understanding the Constitution in a holistic manner.

Student Interaction and Technical Session

The programme then transitioned into an interactive student session. **Ms. Payal Biswas**, a second-year BBA LL.B. student of ICFAI University Tripura, delivered a brief yet insightful address on the Indian Constitution. She emphasized its status as the supreme law of the land and highlighted its role in guaranteeing fundamental rights, upholding democratic values, and ensuring justice, liberty, equality, and fraternity for all citizens.

Thereafter, the host of the programme, **Mr. Ramyak Bhattacharjee**, invited the student speakers for the technical session.

The first presentation was delivered by **Ms. Prajukta Mukherjee**, a fifth-year BA LL.B. student, on the topic “*Transparency or Surveillance: Constitutional Limits on Governance in the Digital Age.*” She thoughtfully examined the constitutional balance between state surveillance for security purposes and the fundamental right to privacy, drawing attention to landmark judicial interpretations and emerging challenges in digital governance.

The second speaker, **Mr. Ramprasad Pal**, a fourth-year BBA LL.B. student, presented on “*Cyber Security and Cyberbullying: Privacy, Dignity and Safety Threats under the Constitution.*” His presentation focused on the impact of cyber threats and online harassment on an individual’s right to privacy and dignity under Article 21 of the Constitution. He emphasized the need for stronger legal frameworks, public awareness, and institutional safeguards to address cyber-related offences. His presentation was well-structured and supported by visual aids.

This was followed by **Ms. Priyashree Sutradhar**, who presented on “*Mental Health of Students: A Constitutional Right to Life, Dignity and Well-Being.*” She highlighted mental health as an integral component of the right to life under Article 21 and stressed the responsibility of the State and educational institutions to ensure a supportive, inclusive, and nurturing environment for students.

Conclusion

At the conclusion of the programme, **Mr. Anikesh Shil**, Convenor of the Constitutional Law Society, delivered the vote of thanks. He expressed sincere gratitude to the dignitaries, faculty members, organizers, and student participants for their valuable contributions and support in making the programme a success.
