Report of One Online Panel Discussion

on

AI & LEGAL REGULATIONS: NATIONAL AND INTERNATIONAL APPROACHES

Introduction: - On **18/3/2025** Faculty of Law, ICFAI University, Tripura has organized one online panel discussion in collaboration with **Center for Human Security Studies**, Hyderabad on AI and Legal Regulations: National and International Approaches. Where eminent speaker from CHSS **Dr. Ramesh Kanneganti**, founder of CHSS and **Dr. Katiyani Juneja Sharma**, Academic Associate of CHSS spoke about AI and its regulations and how it is creating an impact on Human intelligence and Cyber Laws and discussed both International and National approaches. **Dr. A. Ranganath**, Registrar of ICFAI University, Tripura was present in the event. The session was hosted by **Dr. Anindita Choudhury** and **Dr. Raghunath Chakraborty** where Dr. Choudhury introduced the guest with the participants of the webinar. Thereafter **Dr. A. Ranganath** registrar ICFAI University gave the welcoming address where he mentioned the university's willingness to conduct more of such events in collaboration with the Center for Human Security Studies, Hyderabad.

Dr. Zigisha Pujari, Principal Faculty of Law gave a special address where she thanked the resources person for the collaboration between two institute and about the need of the law students to know about AI and its legal regulations.

Thereafter **Dr. Katiyani Juneja Sharma** Academic Associate of CHSS began the session by an introduction to AI regulation followed by a historical context of AI. She mentions about the launch of ChatGPT in late 2022 and the biases it created. There were discussions on Global Regulatory Landscape and how different countries have adopted the Artificial Intelligence and about the recent global trends. India's regulatory approach of AI was also discussed where she mentioned the role of Government bodies and the industrial perspective of AI and the concern of civil society. There was detailed discussion on Government Sentiment on AI Regulation. She discussed about the legal community divisions and about the various policy roadmap for AI regulation in India.

Dr. Ramesh Kanneganti, founder of CHSS spoke about the purpose of Centre for Human Security Service and about its function. He discussed about the internship opportunities available for the students. He further introduced the students of CHSS with the participants of the

webinar which created an environment of mutual friendship. He spoke about AI and why we need more laws to regulate this technology as there is only IT Acts that governs all the laws related to cyber security and about the possible threats. He focused on the importance of AI for the law students and how the citizens can use the technology in a responsible manner.

After the lecture session there was an interaction session between the students and the resource persons where various students asked about their queries regarding AI and the biases it creates between rich and poor, the ethical issues, the probability of Artificial Intelligence taking over Human Intelligence etc.

The session was concluded by a vote of thanks delivered by **Dr. Raghunath Chakraborty**.
