		C.	The First Statutes shall come into force on the date of their framing by the Board of Governors.
		d.	The Headquarters of the Institute of Chartered Financial Analysts of India University shall be situated at Agartala, Tripura.

		 to demand and receive such fees, bills, invoices and collect charges as may be fixed by the Statutes or rules, as the case may be;
		 f. to make provisions for extra curricular activities for students and employees;
		 g. to make appointments of the faculty, officers and employees of the University or a constituent college, affiliated colleges, Regional Centres, Study Centres located in India and abroad;
		 h. to receive donations and gifts of any kind and to acquire, hold, manage, maintain and dispose of any movable or immovable property, including trust and endowment properties for the purpose of the University or a constituent college, or a Regional Centre, Study Centre;

i. 	to institute and maintain halls and to recognize places of residence for Students of the University or a constituent college at the main campus and other campuses in India and abroad;
j.	to supervise and control the residence, and to regulate the discipline among the students and all categories of employees and to lay down the conditions of service of such employees, including their Code of Conduct;
k.	to create Academic, Administrative and support staff and other necessary posts;
1.	to co-operate and collaborate with other Universities and Institutions in such a manner and for such purposes as the University may determine from time to time;
m.	to offer programs on distance learning basis and continuing education and the manner in which such programs are offered by the University;
n.	to organize and conduct refresher courses, orientation courses, workshops, seminars and other programs for teachers, developers of courseware, evaluators and other academic staff;
о.	to determine standards of admission to the University or a constituent colleges, affiliated colleges, Regional Centres, Study Centres with the approval of Academic Council;
р. <i>•</i>	to make special provision for students belonging to the State of Tripura for admission in any course of the University or in a Constituent College, affiliated college, Regional Centre or Study Centre;
q.	to do all such other acts or things weather incidental to the powers aforesaid or not, as may be necessary to further the objects of the University;
r.	to prescribe courses for Bachelor Degree, Master Degree, Doctor of Philosophy, Doctor of Science Degrees and Research and other Degrees, Diplomas, Charters, Certificates etc.
S.	to provide for the preparation of instructional materials, including films, cassettes, tapes, video cassettes, CD, VCD and other software;
t.	to recognize examinations or periods of study (whether in full or in part) of other Universities, Institutions or other places of Higher learning as equivalent to examinations or periods of study in the University and to withdraw such recognition at any time;
u.	to raise, collect, subscribe and borrow with the approval of the Board of Governors whether on the security of the property of the University, money for the purposes of the University;
ν.	to enter into, carry out, vary or cancel contracts.
w.	to do all things necessary or expedient to exercise the above powers.

4.0A	The powers of Visitor	The Governor of Tripura will be the Visitor of the University.
		The Visitor shall, when present, preside at the Convocation of the University for conferring Degrees, Diplomas, Charters, Designations and Certificates.
		The Visitor shall have the following powers to be exercised in accordance with the procedure laid down in the Statutes, namely:
r F		 To call for any paper or information relating to the affairs of the University;
		b. On the basis of the information received by the Visitor, if he is satisfied that any order, proceeding, or decision taken by any authority of the University is not in conformity with the Act, Statutes or Rules, he may issue such directions as he may deem fit in the interest of the University and the directions so issued shall be complied with by all concerned.
		The Visitor may exercise any of the above powers in such manner as he deems fit by addressing the Board of Governors, the Board of Management, the Chancellor, the Vice Chancellor or Registrar '
		The Visitor may call for copies of supporting documents and decide the matter after granting a hearing to the authority whose order, proceeding, or decision is called;
		The Visitor may communicate his final decision or direction or order to any of the above authorities for compliance.
5.0	Appointment and powers of the Chancellor	a. The Chancellor shall be appointed by the Sponsor with the prior approval of the Visitor.
		b. The term of office of the Chancellor shall be five years, and he may be reappointed for successive terms, at the pleasure of the Sponsor.
		c. The Chancellor shall be the Chairman of the Board of Governors and the head of the University.
		 The Chancellor shall preside at the meeting of the Board of Governors and shall, when the Visitor is not present, preside at Convocation of the University
		 e. The Chancellor shall have the following powers: i To call for any information or record.
}		ii To appoint the Vice-chancellor. iii To remove the Vice-chancellor.
		iv Such other powers as may be conferred on him by the Act or the Statutes made thereunder or as may be delegated to him by the Board of Governors
		f. If in the opinion of the Sponsor, the actions of the Chancellor are found to be in any way detrimental to the interests of the University, the Sponsor shall appoint such other person as may be found appropriate in the position of Chancellor to succeed the person so acting. Provided that, the Sponsor shall seek the prior approval of the Visitor before appointing such other person as the Chancellor. The Sponsor may stipulate the date from which such other person shall assume the office of the Chancellor.
		g. The office of the Chancellor may be located anywhere in India or overseas.

		b.	The term of office of the Vice-chancellor shall initially be Four years, and he may be reappointed, by the Chancellor, after expiration of the initial term, for another term not exceeding four years.
		с.	The Vice Chancellor shall draw such emoluments which shall not be less than the emoluments prescribed by the UGC from time to time.
		d.	The Vice-chancellor shall be the principal executive and academic officer of the University; he shall be the Chairperson of the Board of Management, Chairman of the Academic Council, and Chairman of the Finance Committee and other Committees that may be set up by the Board of Governors or the Board of Management from time to time.

The Vice Chancellor shall exercise general supervision and control over the affairs of the University and shall give effect to the decisions of the authorities of the University; and shall exercise such other powers and perform such other duties as may be laid down by the Act, the Statutes or the Rules
		f.	In absence of both the Visitor and the Chancellor, the Vice-chancellor shall undertake all the functions of the Chancellor, and shall preside over the Convocation.
		g.	If in the opinion of the Vice-Chancellor it is necessary to take immediate action on any matter for which powers are conferred on any other authority by or under this Act, he may take such action as he deems necessary and shall at the earliest opportunity thereafter report his action to such officers or authority as would have, in the ordinary course, dealt with the matter:
			Provided that if in the opinion of the concerned authority such action should not have been taken by the Vice Chancellor, then such case shall be referred to the Chancellor; whose decision there on shall be final.
			Provided further that where any such action taken by the Vice-Chancellor affects any person in the service of the University, such person shall be entitled to prefer, within three months from the date on which such action is communicated to him, an appeal to the Board of Governors and the Board of Governors may confirm or modify or reverse the action taken by the Vice Chancellor.
