This Memorandum of Understanding (MOU) is made on the 28th Day of November, 2024

The Center for Human Security Studies is a non-governmental, non-political and non-profit Society established under AP Societies Registration Act 2001. It is a non-political think tank with Human Security as its overall focus and National Security & External Affairs of India at the core of its interest and it is situated at 65N, MCRHRD Institute of Telangana, Road Number 25, Jubilee Hills, Hyderabad, Telangana 500033 (hereinafter called as "CHSS"), represented by **Dr. Kanneganti Ramesh Babu**, Founder & Executive Director of CHSS, which expression shall unless repugnant to the context or meaning thereof, be deemed to include its successors, legal representative and permitted assigns;

AND

The ICFAI University Tripura, a University established under Section 4(2) of The Institute of Chartered Financial Analysts of India University Tripura Act of 2004, enacted by the State of Tripura, having its Campus at Village Kamalghat under Mohanpur Sub Division in West Tripura district-799210 (hereinafter called as "IUT"), represented by Registrar **Dr. A Ranganath**, which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns.

CHSS and IUT are independently referred to as 'party, and collectively as "parties". The parties agree to engage into broad spectrum of joint activities in the fields of promotion of educational programmes, Joint Research Activity, Exchange of knowledge Resources Programme, Training programmes, Collaborative Consultancy & Projects etc.. This MoU shall be treated as the guidelines on which both parties agree to work together in future. The terms and conditions of this MoU are mentioned in following para:

1. BACKGROUND

The Center for Human Security Studies is a non-governmental, non-political and non-profit Society established under AP Societies Registration Act 2001. It is a non-political think tank with Human Security as its overall focus and National Security & External Affairs of India at the core of its interest. It is analyzing, developing and promoting policy solutions and providing a range of strategies and best practices for Transforming Public Policy and focus on various socio-economic issues not limited to internal security, food security, water security, cyber security, counter terrorism mechanisms, coastal and maritime security, Indian foreign policy and Indian Diaspora relations. Both the parties will negotiate and enter into a definitive agreement, signed by each party or its authorized signatory , describing the terms of the arrangements, including but not limited to financial commitments, academic freedom commitments, immigration and compliance obligations and details of exchange or collaborative relationship. This MOU is not intended to create any legally binding obligations on either party but , rather it is intended to facilitate discussions regarding general areas of cooperation.

4. PERFORMANCE STANDARD

The parties shall perform their respective roles and responsibilities under this MoU with highest standards of professional and ethical competence and integrity. Both Parties shall also respect rules, regulations and policies of both institutions.

5. VALIDITY OF MoU

This MoU shall have provision of periodic review of the activities and progress. This MoU shall be valid initially for a period of **five years**, which can be extended by mutual agreement. Any cessation of this MoU by either Party shall be notified in writing to the other Party at least 3(three) months in advance in writing.

6. ARBITRATION

Dispute arising out of this MoU, if any, shall be amicably settled by the parties




