



## Memorandum of Understanding

This agreement is made on 28<sup>th</sup> day of April, 2022

BETWEEN

**The ICFAI University Tripura**, Agartala-Simna Road, P.O Kamalghat, West Tripura is a University established in 2004 through an Act of State Legislature (Tripura Act 8 of 2004) herein after called IUT,

AND

**Foundation 3H** is a Govt. Regd. Society under Society established under the societies registration Act 1860 bearing Reg. No. 8611 of 2021 situated at Ker Chowmuhani, Agartala, Tripura- 799001 herein after called Foundation,

### **PREAMBLE**

**The ICFAI University, Tripura** was established under the provisions of the Institute of Chartered Financial Analysts of India (ICFAI) University, Tripura Act 2004 (Act No.8 of 2004), vide Government of Tripura Notification No. F.2 (529)-DHE/UDCA/2003 dated 15.06.2004. The University Tripura is approved, recognized and listed by the UGC, under Section 2(f) of the UGC Act, 1956.


**FOUNDATION 3H** is registered under the Societies Registration Act, 1860 bearing no: 8611 of 2021. It is a non-governmental organization working for the welfare of person with disabilities. The Foundation 3H was established by a team of eleven members comprising of active social workers from various professions, currently presided by Mr. Premangshu Chakraborty. The Foundation is currently working under the Bamutia block and has conducted several awareness programmes in the field of disability. It is also conducted various family visits and field survey.

### **COLLABORATION AGREEMENT**

The discussions and interactions between IUT, Faculty of Special Education and FOUNDATION 3H indicated that they share common mission, objectives and ideology – that is Counseling for rehabilitation educational programme to mentally retarded (Intellectual Disabled ) children.

- Diagnosis of mentally retarded (Intellectual Disabled ) and other impairment children
- Practical Exposure in Special school (IEP as well as Teaching Practice).
- Research, knowledge generation and publication
- Involvement of Faculties / Students of IUT to Diagnose ID cases in FOUNDATION 3H,

### VALIDITY OF THE AGREEMENT

The agreement will come into force from the date of signing and will be valid for a period of 5 (five) years. During this period, either party will be free to terminate the agreement with one month's notice in writing.


