3. The HEI shall adhere to various directives issued by the Commission and other relevant statutory/ regulatory bodies/authorities from time to time.

In the event of any Higher Educational Institution found offering programmes in Open and Distance mode and/or Online mode without recognition of the Commission or in violation to any of the provision(s) of these regulations and guidelines or orders made there under, the Commission may take actions as per Regulation 7 in Part -II of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and the Higher Educational Institution shall be solely responsible for career consequence of the students, if any, arising out of the same.


5. The other terms and conditions shall remain same as communicated in the previous Commission Orders.
